The Data, Transparency, and Future of Blockchain Research Workshop

One of the greatest features of blockchains is the transparency they bring. However, despite this feature, the large collections of blockchain data are highly unexplored and underutilized. In this workshop, Dr Jahanshahloo, the creator of Cardiff University Bitcoin Database (CUBiD), will explore the applications of blockchain data and how it can be exploited by academics, financial authorities, regulatory bodies, and practitioners. Based on his own experience in blockchain research, Dr Jahanshahloo will share his views on the prospects of future research as well as the benefits analysis of blockchain data can deliver in different fields.
