## Call for Papers

**Background:**

Industry and trade in goods and services grow on strong consumer demand; the pandemic wave, inflation, and geopolitical tensions have contributed to the deterioration of consumers' purchasing power and hence present risk to economic growth in 2022. Although, the COVID-19 pandemic, the Russian Ukrainian war, and the associated supply bottlenecks have severely disrupted the financial, labor, and goods & services international flows, global trade will nonetheless become more important and expected to continue expanding in 2022 and in 2023. In addition, empirical research has already confirmed the strong links between international trade liberalization and various aspects of socio-economic development.

Taking into accounts these unexpected international developments, the main objective of this conference is to share knowledge and expertise on the New Economy in the context of post-pandemic reality, technological changes, and its application to the economy, fastening digital transformation and the rising importance of sustainable development. The conference will present the recent developments in international trade policies and provide a quantification of the effects of trade policies and their impact on inequalities and other economic development indicators. It aims to bring together leading academic scientists, researchers and research scholars to exchange and share their experiences and research results on the recent global developments and its reflections on Economics, Business and finance environments. It also provides a premier interdisciplinary platform for researchers, practitioners, and educators to present and discuss the most recent innovations, trends, and concerns as well as practical challenges encountered and take new initiatives with the collaboration of academia, industry and policymakers across the globe.

Under the umbrella of the WTO-Chair program, the Chairs of the University of Jordan, the University of Cairo, the University of Chile, the University of Egypt, Instituto Tecnológico Autónomo de México (ITAM), the University of Mauritius, the University of Oman, the University of Tunis, University of Turkey, and the University of the West Indies, invite scholars, government policy makers, practitioners, and other interested parties from all over the world to participate in the Seventh International Conference on: "Contemporary Issues in International Trade: A Development Lens". Empirical research presentations, and country context case studies along the conference themes as well as other related issues from all over the globe are welcomed. Delegates are invited to present completed research papers and/or work in progress. Submissions and presentations must address both the theoretical and practical implications of the findings. Parallel tracks of refereed presentations will enable authors to obtain constructive feedback on their study.

**Submission Guidelines:**

- The research should be original.
- The research should be in line with the main themes of the conference and linked to the conference's sub-themes and written in Arabic, English, French, and Spanish.
- The abstract should be of no more than 400 words.
- Submitted papers will be evaluated by the scientific committee of the conference.
- Papers should be submitted electronically (as a word.doc attachment) Accepted papers should be no more than 7000 words.
- Papers submitted in Arabic must use; font (Arabic Transparent), size (14), 5.2 cm margins for the four sides, and double spaced, including the reference list. Papers submitted in English must use; font (Times New Roman) size (12), and double spaced.
- Authors contact information should include: (first, middle and surname), in addition to university affiliation and e-mail address.
- Accepted papers may be optionally published in a special issue in the Jordan Journal of Economic Sciences (<https://journals.ju.edu.jo/JJES>). The journal is published in both Arabic and English by the University of Jordan. Research manuscripts presented for publishing are anonymously and blindly refereed.

Final papers should be sent to the conference administration no later than December 1, 2022 to the email [wtochair.jordan@ju.edu.jo](mailto:wtochair.jordan@ju.edu.jo); cc: [t.awad@ju.edu.jo](mailto:t.awad@ju.edu.jo), which will then be sent to the journal to be published in a special issue after its scientific arbitration by the journal, based on the journal policy. In addition, all accepted papers abstracts will be published in conference booklet and certificates will be granted to participants.
